CVS is proud to share we have a Drop Trailer Program with ‘less than truckload (LTL)’ carriers shipping freight inbound prepaid to our Distribution Centers (DC). The program was implemented to reduce congestion at our DCs, improve efficiencies and reduce costs. We have two classifications, PREFERRED and APPROVED LTL carriers. The details of each are as follows.

**PREFERRED CARRIERS:**

As a preferred LTL carrier, CVS assumes the expenses associated with sorting and segregation for unloading the trailers in this program. If the shipment is given to a preferred carrier in a timely manner, suppliers will not be responsible for missed or late deliveries.
